

**Regulation No. 17/2019  
of Rector of the Medical University of Gdańsk  
as of March 4, 2019  
on the division of the academic year 2019/2020**

Pursuant to art. 66 of an Act of 20 July 2018 on Higher Education (Journal of Laws of 2018 pos. 1668 as amended), under § 3 of the Rules of Study appended to the Medical University of Gdańsk Senate Resolution no. 22 /2018, and in conjunction with § 31, item 4 of the MUG Statute as of 8 June 2006,( i.e. Annex no. 1 to the Resolution No. 21/ 2018 of the MUG Senate as of 23 April 2018)

**it is hereby ordered as follows:**

**§1**

The academic year 2019/2020 at the Medical University of Gdańsk begins on 01.10.2019 and lasts until 30.09.2020 and is subdivided as follows:

<b>Winter semester</b>	<b>from 01.10.2019</b>	<b>to 16.02.2020</b>
regular classes	from 01.10.2019	to 26.01.2020
Christmas break	from 23.12.2019	to 06.01.2020
winter examination session	from 27.01.2020	to 02.02.2020
semester break	from 03.02.2020	to 09.02.2020
winter repeat examination session	from 10.02.2020	to 16.02.2020
<b>Summer semester</b>	<b>from 17.02.2020</b>	<b>to 30.09.2020</b>
regular classes *	from 17.02.2020	to 07.06.2020
Easter break	from 09.04.2020	to 15.04.2020
summer examination session	from 08.06.2020	to 28.06.2020
summer repeat examination session	from 31.08.2020	to 13.09.2020
dean's time limit for appeal	from 14.09.2020	to 30.09.2020

**Note:**

- \*Summer semester for Pharmaceutical and cosmetics manufacturing and the 6<sup>th</sup> year of Medical Faculty – Polish and English Division may last till 21.06.2020
- 08.10.2018 there will be Rector's Hours due to the inauguration of the academic year
- Orientation course for first-year students of English Division from 23.09.2019 to 29.09.2019
- The examination session dates do not apply to students doing their courses in the block system; in this case the continuous examination session system applies (the examinations are held directly upon completion of the relevant course block).
- Vocational training consistent with the programme of studies is obligatory during the academic year

**§2**

The subdivision of the academic year for students who take the diploma exam and defend the diploma thesis is as follows:

**Year division for final year students of those fields of study which end with the diploma examination and the diploma thesis defense**

regular classes	from 17.02.2020	to 30.04.2020
summer examination session	May 2020	
diploma thesis defense	June 2020	


**§3**

The subdivision of the academic year for part-time students is as follows:

<b>Year division for part-time students</b>		
<b>Winter semester</b>	<b>from 01.10.2019</b>	<b>to 16.02.2020</b>
regular classes in the winter semester	from 1.10.2019	to 16.02.2020
<b>Summer semester</b>	<b>from 17.02.2020</b>	<b>to 30.09.2020</b>
regular classes in the summer semester	from 17.02.2020	to 30.07.2020
Part-time students have no semester break, or any strictly defined examination session. The examinations are held directly upon completion of the specific course. The repeat examination session must end by 13.09.2020
